PRESIDENT'S REPORT

David Sparrow reported on the following:

- Thanks to the work of FilmOntario, amendments were made to the Ontario budget to "grandfather" current productions from the announced budget changes.
- ACTRA Toronto will be making a submission to the Changing Workplaces Review Panel looking at possible changes to the Labour Relations Act and Employment Standards Act.
- June 28th is the Pride Parade and Elvira Kurt will be ACTRA Toronto's Pride Parade Ambassador.
- The Toronto International Deaf Film and Arts Festival ran from May 27th to May 31st. Mr. Sparrow attended. ACTRA Toronto Member Catherine MacKinnon is a co-founder and Director of the festival.
- At the recent TAWC Spring Gala, the Nell Shipman Award was presented to Laurie Finstad-Knizhnik, creator, writer and showrunner of *Strange Empire*, as well as Executive Producer of *Durham County*.
- At the AFBS AGM, Tom Jackson was presented with the Leslie Yeo Award for volunteerism.
- Launch date of *Casting ACTRA* is June 10th. This site will replace *Face to Face*.

 Mr. Sparrow also reported on ROI, CRTC decisions, the Legacy Project, Performing Arts Preparation Professional Advisory Council at Sheridan College, the Full Member Background Committee Meeting and the TAMAC Agents meeting.

David reminded everyone that there will be no Council meeting in July. The next meeting of Council will be on Tuesday, August 4th. David also reminded Councillors of the upcoming Council elections.

EXECUTIVE DIRECTOR'S REPORT

Sue Milling reported on the Ontario Budget and the work done by FilmOntario to lobby for the amendments. Sue announced that Brian Topp on accepting the position of Chief of Staff to the new Premier in Alberta had to resign

from the Co-chair position on FilmOntario. Brian will continue to be active with CASCU.

She also reported on the objectives for ACTRA Toronto's submission on the Changing Workplaces Review: recognition of our agreements; and Employment Standards legislation to cover self-employed contractors. A meeting has been organized for the end of June with all the union and guilds to discuss a joint submission to the

consultation panel.

Work on simplifying the National Commercial Agreement is on-going. Sue also reported on the work of our Industry Relations staff in reaching out to producers and engagers who have not yet worked with ACTRA.

Ms Milling assumed the Chair.
