VOLUNTARY RECOGNITION AGREEMENT

(see Article A103)

I, _____, (print name of individual), on behalf of the Producer, hereby acknowledge receipt of the Independent Production Agreement, effective from January 1, 2022 to December 31, 2024 and covering Performers in independent production, between the Canadian Media Producers Association ("the CMPA"), the Association Québécoise de la Production Médiatique ("AQPM") and the Alliance of Canadian Cinema Television and Radio Artists ("ACTRA") and state that I am authorized to execute this Agreement on behalf of _____ (the "Producer", as per A434).

The Producer hereby acknowledges that by executing this Voluntary Recognition Agreement, it is becoming signatory to the said Agreement. The Producer agrees to abide by and conform to all the terms and conditions contained herein.

The Producer recognizes that ACTRA is the exclusive bargaining agent of Performers as defined in the IPA, and recognizes the Producer's Association of which it is a member as the Producer's sole and exclusive bargaining agent.

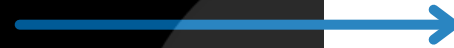

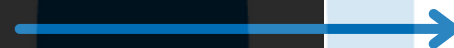
